were submitted by the manufacturer to the assessment of the performance of the construction products, are submitted by the manufacturer to a factory production control and to the further testing of samples taken at the factory in accordance with a prescribed test plan, and that the notified body – CSTB – has performed the initial inspection of the manufacturing plant and of the factory production control and performs the continuing surveillance, assessment and evaluation of the factory production control (system 2+).

This certificate attests to that all provisions concerning the assessment and evaluation of factory production control described in the harmonized reference technical specification:

EN 13969: 2004 + A1: 2006

are applied and that this factory production control fulfills all the prescribed requirements.


This certificate can only be used in conjunction with the declaration of performance of the product written by the manufacturer or his authorised representative established in the European economic area and with the technical specification in reference.

This certificate is issued on 14 February 2022, it replaces the certificate previously delivered on 26 July 2019 and, except for withdrawal or suspension, remains valid as long as the conditions laid down in the corresponding technical specification in reference or the manufacturing conditions in the factory or the factory production control itself are not modified significantly.

This certificate comprises 2 pages.
