are submitted by the manufacturer to a factory production control and to the further testing of samples taken of the factory in accordance with a prescribed test plan, and that the notified body - CSTB - has performed the assessment of the performance of the construction product(s), the initial inspection of the manufacturing plant and of the factory production control and performs the continuing surveillance, assessment and evaluation of the factory production control (system 1).

This certificate attests to the products performances, relative to the fire reaction performance chosen by the manufacturer, and that all provisions concerning the assessment and verification of constancy of this (these) performance(s) described in the harmonised reference technical specification:

EN 14509: 2013

are applied and that the products fulfill all the prescribed requirements.


This certificate can only be used in conjunction with the declaration of performance of the product written by the manufacturer or his authorised representative established in the European economic area and with the technical specification in reference.

This certificate is first issued on 30/06/2021 and, except for withdrawal or suspension, remains valid as long as the conditions laid down in the corresponding technical specification in reference or the manufacturing conditions in the factory production control itself are not modified significantly.
